

COVID-19 ACKNOWLEDGEMENT AND LIABILITY RELEASE

This Release is executed and made effective as of _____, 2020. The undersigned ("Releasor"), on Releasor's own behalf and that of Releasor's family members, friends, guests, invitees, agents, employees, representatives, successors, and assigns ("Related Parties"), hereby releases and discharges LLR Inc., a Wyoming corporation, and LuLaRoe, LLC, a California limited liability company (collectively, "Company"), and its principals, members, officers, directors, employees, agents, affiliates, representatives, successors, and assigns, from any and all claims, rights, actions, damages, losses, and harm, known and unknown, including, without limitation, bodily injury or death, arising or related in any way to exposure to COVID-19 at any event sponsored by the Company, including all related activities ("Event").

Releasor and the Related Parties acknowledge and understand that: (1) there is a risk that now or subsequent to the execution of this Release, Releasor may have, or may discover, some claims, rights, actions, damages, or losses, including, without limitation, bodily injury or death, that are unknown and unanticipated at the time this Release is executed; and (2) that some claims, rights, actions, damages, or losses, including, without limitation, bodily injury or death, which are presently known or which should be known may become more serious than now expected or anticipated. Nevertheless, Releasor and the Related Parties hereby expressly waive all rights they may have in such unknown and unexpected consequences or results as if those claims, rights, actions, damages, or losses, including, without limitation, bodily injury or death, were known or should have been known to Releasor and/or the Related Parties at the time of execution of this Release. Releasor and the Related Parties agree that this Release shall be given full force and effect in accordance with each and all of its express terms and provisions, including those terms and provisions relating to unknown and unsuspected claims, rights, actions, damages, or losses, including, without limitation, bodily injury or death, to the same effect as those terms and provisions relating to any other such claims released herein. To the fullest extent applicable, Releasor and the Related Parties knowingly and expressly waive the provisions of California Civil Code Section 1542 pertaining to General Releases. California Civil Code Section 1542 provides: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor." Releasor and the Related Parties represent that neither Releasor nor the Related Parties have assigned, sold or transferred, or purported to have assigned, sold or transferred, any of the rights or claims which are the subject of this Release.

This Release constitutes the entire agreement pertaining to the subject matter contained in it and supersedes all prior and contemporaneous agreements, representations and understandings. No waiver of any provision of this Release shall be binding unless executed in writing by the party making the waiver. If any provision of this Release shall, for any reason, be held unenforceable, such provision shall be severed from this Release, the invalidity of such specific provision, however, shall not affect the enforceability of any other provision herein, and the remaining provision shall remain in full force and effect. This Release is deemed to have been entered into in Riverside County, California. This Release shall be construed in accordance with, and governed by, the laws of the state of California.
